Season's Greetings,




cross your fingers for something new in 2026. Read on!


Here's this month's question and answer:

The motel was about to be torn down a few years back, but ended up being designated a Mississippi Landmark after a public outcry. They still demolished a lot of it, but the sign survived."

"And now we have a nice place to eat breakfast," I say as I peruse the menu.

"See anything you like?" Harper asks a minute later.

I make a point of looking at my watch. "I do, but we don't have time for me to work through all of them. You?"

"Same, but I'm gonna go with 'Which Came First.'"

I'm also tempted by the chicken and egg breakfast sandwich—if only because of its playful twist on the age-old chicken and the egg quandary—but I opt instead for "THEE Breakfast", which more closely resembles the carb-loaded monstrosities of eggs and sausage and toast and potatoes I'm partial to ... and which may well be the death of me.
